The aim of this course is to provide an objective overview of the attributes of commercial property as a mainstream asset class and to lay down the theoretical foundations of investment decision-making, so that particular decisions regarding property investments can be made efficiently and rationally.

Concepts and techniques included in this course and problem sets are used in many careers related to real estate. These include periti, real estate advisors and valuers, investors and developers, estate agents and CFOs. This material is also relevant to individuals who want to better understand real estate for their own personal investment decisions as it prepares the student to understand the risks and rewards associated with investing in and financing both residential and commercial real estate.

Characteristics of property investments;

The property market and international/ foreign real estate investment;

The real estate portfolio and portfolio theory;

Real estate investment decision making and strategies;

Responsible property investments and the impact of ESG;

Analysing investment properties and understanding the KPIs;

The course will include practical examples and key considerations, and resources to follow to be up to date with international best practice.
