It typically involves examining various factors such as financial, technical, operational, legal, and environmental considerations to assess whether the proposed undertaking is realistic and achievable. The aim is to assist stakeholders in recognizing potential challenges, risks, and opportunities, thereby enabling informed decision-making prior to resource allocation.
