# Global Updates to Real Estate Valuation

#### Course No 240

This course will focus on the RICS Independent Review of Real Estate Investment Valuations, published in December 2021, which is a sector changing document that includes a series of recommendations that aim to improve confidence in property investment valuations, and the process by which they are undertaken and reviewed around the world. The recommendations were UK orientated but the recommendations that related to discounted cash flow (DCF) valuations and analysis apply globally.

This course is essential for enhancing property valuers and valuation users' understanding and proper application of the DCF method. Attendance to this course will add to the advancement of knowledge within real estate valuation practice globally.
