During the meeting of the Board of Directors of the Company held today, 23 April 2025, the Board of Directors approved the Company's audited financial statements for the financial year ended 31 December 2024.

For the purposes of Capital Markets Rule 5.16.24, it is hereby reported that profit before tax for the financial year ended 31 December 2024 amounted to  $\in$ 108,481, giving rise to a variance (positive) of over 10% when compared to the financial analysis summary annexed to the final terms published by the Company on the 25 September 2024, which projected a loss before tax of  $\in$ 129,000. The variance is attributable mainly to a decrease in administrative expenses of  $\in$ 282,366.
