#### Quote

The Board of Directors of the Company has today approved the audited consolidated financial statements for the financial year ended 31 December 2024.

The total revenue generated for the year amounted to  $\in 1,443,000$  as against a forecast of  $\in 1,448,000$ . Earnings before interest, tax, depreciation and amortization (EBITDA) amounted to  $\in 2,109,000$  against a forecast of  $\in 1,412,000$  and the net profit for the year amounted to  $\in 886,000$  (as against  $\in 368,000$ ). The difference in the results is largely due to the following factors:

- 1) A higher fair value movement on investment properties (€919,000 as against a forecast of €200,000);
- 2) A higher deferred tax expense mainly resulting from the movement in fair value on investment properties ( $\[ \in \]$  326,000 as against a forecast of  $\[ \in \]$  113,000).
