COMPANY ANNOUNCEMENT

Malfacom p.l.c. wishes to announce that it has today, Friday, the 20th of May, 2005, held its Seventh Annual General Meeting at the Hilton Malta Conference, Centre, in St. Julian's

The shareholders convened for this event, discussed and approved the following ordinary Resolutions:

- That the Annual Report and Financial Statements of the Company for the year ended 31st December, 2004, comprising the Financial Statements and the Directors and Auditors Report thereon, be hereby received and approved.
- That the Meeting approves the payment of a net Dividend of Lm 0.02c1 (after taxation) to all shareholders of Maltacom p.l.c. registered at the closure of business on the 22nd of April, 2005.
- That the reappointment of Messrs KPMG Certified Public Accountant, be hereby approved, and the Board of Directors be hereby authorised to establish their remuneration.
- To establish the maximum annual aggregate emoluments of the Directors at Lm150,000.
- that Directors be elected in accordance with Article 55.3 (b) of the Memorandum and Articles of Association of the Company.

The shareholders were informed that the Government of Malta by virtue of its being the major shareholder of the Company, had reappointed Mr. Saviour Portelli as Chairman and Mr. Vince Farrugia, Ing. Alexander Tranter, Mr. Alfred Rizzo and Dr. Chris Said L.L.D. as its Directors on the Company's Board of Directors.

As far as the other three vacant Directorships were concerned, in view of the fact that there were only three candidates for the said posts, the meeting reappointed Mr. John Ellul Vincenti, Mr. Peter J. Baldacchino and the Noble Paul Testaferrata Moroni Viani as Board Directors.

Mr. Saviour Portelli - Chairman of the Board of Directors.

Mr. Saviour Portelli, aged 59, started his career in the Malta Civil Service. He left the service in the late 70's to join the tourism industry, and has since successfully held a number of senior management appointments in various areas of this field.
