During the meeting of the Board of Directors of Mizzi Organisation Finance plc (the "Company") held today, 28 April, 2023, the Board of Directors of the Company approved the Company's audited financial statements for the financial year ended 31 December, 2022. The audited financial statements of the Company are available for viewing on https://mofplc.com/investor-relations/financial-statements/. Attached to this Company Announcement is a Directors' Declaration on ESEF Annual Financial Reports.

For the purposes of Capital Markets Rule 5.16.24, it is hereby announced that the Company registered a profit before tax amounting to €57,000. After accounting for taxation, the net profit amounted to €38,000. The financial analysis summary published on 28 June 2022 indicated a projected profit after tax for the year ending 31 December, 2022 of €43,000. The 11.6% variance, amounting to €5,000, is attributable to higher administration costs.

As already announced in Company Announcement MOF 78/2023, the audited financial statements for the financial year ended 31 December, 2022 of Mizzi Organisation Limited (C813), Consolidated Holdings Limited (C1192), The General Soft Drinks Company Limited (C1591) and GSD Marketing Limited (C3774), the guarantors of the €45,000,000 3.65% Unsecured Bonds 2028-2031 issued by the Company in terms of the prospectus published by the Company on 24 September, 2021 (the "Guarantors"), will be made available for viewing on the webpage referred to above, in accordance with Capital Markets Rule 5.61, by 30 April, 2023. In addition to the aforesaid, the Company shall also make available for viewing the combined audited financial statements for the financial year ended 31 December, 2022 relative to The Mizzi Organisation, the conglomerate of companies which includes, amongst others, the Company and the Guarantors, and in respect of which reference was made in the said prospectus.
