No questions relative to the Remuneration Report were received in advance of, or raised at, the Annual General Meeting.

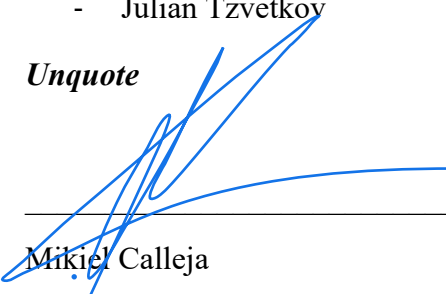
Appointment of Directors
