During the meeting of the Board of Directors of Virtu Finance p.l.c. (the "Company") held today, 28 April, 2025, the Board of Directors of the Company approved the audited financial statements of the Company for the financial year ended 31 December, 2024.

The audited financial statements of the Company are available for viewing on <a href="http://www.virtu.com.mt/investor-downloads/">http://www.virtu.com.mt/investor-downloads/</a>. Attached to this company announcement is a Directors' Declaration on ESEF Annual Financial Reports.

Furthermore, with respect to Virtu Maritime Limited (C-81559), the guarantor of the €25,000,000 3.75% Unsecured Bonds 2027 issued by the Company in terms of the prospectus dated 30 October, 2017, it is hereby announced that the audited consolidated financial statements for the financial year ended 31 December, 2024 have been approved by its board of directors on the date hereof, and have been made available for viewing on the webpage referred to above in accordance with Capital Markets Rule 5.61.

The consolidated profit before taxation of the Virtu Maritime Group for the year ended 31 December 2024 amounted to €21.12 million. These results show an improvement of €8.8 million in profits before tax when compared with those forecast in the Financial Analysis Summary (FAS) that was published on 25 June 2024. This improvement in profits can be attributed in the main to revenue arising from a short-term charter in the Eastern Mediterranean which was not anticipated at the time of the preparation of

the FAS, and to stronger than expected demand on the Malta/Sicily high speed ferry service in passenger numbers and vehicular traffic across all categories together with moderating fuel costs.
